Definitions:

Police Records Check

Download a Police Records Check formThis service is restricted to applicants seeking employment and/or volunteer work with *vulnerable** individuals. This includes national and local police databases. The possible existence of criminal convictions and outstanding charges, as well as incidents of all notable police contacts for at least the previous five years will be considered for release. Information is collected and disclosed according to section 29(1) and 32 of the Municipal Freedom of Information and Protection of Privacy Act and the Police Services Act, RSO 1990, c.P.15

Criminal Records Check

This service is intended for applicants who are involved as a volunteer, employee or in any situation where a basic criminal background check is requested (i.e. retail, warehouse or immigration). This search is not intended for applicants who are seeking volunteer and/or employment with *vulnerable* * persons. This search includes national databases only. The possible existence of criminal convictions and outstanding charges will be considered for release. Information is collected and disclosed according to section 29(1) and 32 of the

*Who are vulnerable persons?

Vulnerable persons or individuals refers to a class of persons who, because of their age, a disability or other circumstances, whether temporary or permanent are in a position of dependence on others or are otherwise at a greater risk than the general population of being harmed by persons in a position of authority or trust relative to them (e.g. children, disabled or elderly)

If the person requesting the Records Check is under the age of 16 years and does not have sufficient identification a parent or legal guardian (with proper identification) can guarantee the young person's identity.
